

## **KIDS FLAUNT CONTEST**

### **Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

**1. HOW TO ENTER.** Go to [scholastic.com/flauntit](http://scholastic.com/flauntit) from September 24, 2018, at 12:01 a.m. ET to November 21, 2018, at 11:59 p.m. ET and download the lesson plan, the student activity sheet, and the contest entry form. Have your students complete the activity described in the lesson plan and student activity sheet and fill out the entry form. Once their parents have signed the entry form (and included an optional photograph) and after the students have completed their entries, the teacher can submit the student entries in one of two ways: by mail to Kids Flaunt Contest, Scholastic Inc., 557 Broadway, ATTN: M. ONLY A STUDENT'S TEACHER MAY SUBMIT THE ENTRIES. Teachers must mail or email the contest entries. Each entry must be on standard letter size paper (8.5 x11 inches.) Please make sure each entry is attached to a corresponding contest entry form.

To enter the contest, the teacher will lead and guide students to write an essay, write a poem, or create a 2-D piece of artwork accompanied by a few sentences to explain the artwork about the personal qualities that make them unique, following the prompts provided on the contest entry form at [scholastic.com/flauntit](http://scholastic.com/flauntit).

It is essential for the proper and legitimate operation of this contest that each entry must be the student's own original work and cannot contain previously published and/or copyrighted material.
