

**SCHOLASTIC  
TINY SMILES POST-PROGRAM SURVEY SWEEPSTAKES  
OFFICIAL RULES**

**1. TO ENTER: NO PURCHASE NECESSARY TO ENTER OR WIN.** Void where prohibited. A purchase will not improve your chances of winning. To enter the Tiny Smiles Post-Program Survey Sweepstakes (the “Sweepstakes”), visit [scholastic.com/givekidsasmile/survey](https://scholastic.com/givekidsasmile/survey) and complete the online survey between 12:01 a.m. Eastern Time (“ET”) on October 1, 2019, and 11:59 p.m. ET on April 3, 2020 (the “Entry Period”). Only one entry per person. In the event of a dispute over the identity of the owner of an online submission, entry will be deemed submitted by the holder of the email account submitted in connection with the entry. The survey must be filled out in good faith, and incomplete entries will be discarded.

**2.
