OFFICIAL RULES**

CONTEST: Goosebumps Horrorland Webcast Contest

SPONSOR: Scholastic Inc., 557 Broadway, New York, NY 10012

ELIGIBILITY: Contest is open only to legal residents of the USA ages 8-12. Subject to all applicable federal, state and local laws.

NO PURCHASE NECESSARY: You can enter the contest on-line or by mail. Entrants must choose one of three story starters provided by R.L. Stine and finish it in their own words, entries must not exceed 500 words and be written in the English language. Complete the form in the Contest section and submit the form online along with the completed story to enter the contest.
