

TINY TRAVELERS SWEEPSTAKES OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A purchase will not improve your chances of winning. In the event of a dispute over the identity of an online entrant, entry will be deemed submitted by the holder of the e-mail account.
