Official Rules: The (Really) Great Outdoors Contest

1. TO ENTER: NO PURCHASE NECESSARY TO ENTER OR WIN. To enter The (Really) Great Outdoors Contest (the "Contest"), an Eligible Student (as defined below) must write and/or draw a nature space that his or her community could use, explaining what elements are needed in their space, their purpose, and how he/she and others will enjoy them (the "Entry").

The Eligible Student can mail the Entry to the address below, or provide the Entry to their Submitting Teacher (as defined below) to either mail in or to submit electronically at the contest website at scholastic.com/turfmutt. Only a Submitting Teacher can upload entries electronically; students are not allowed to upload entries electronically.

In addition, each Entry must be no more than three pages, and must include the following information also: the student's name, grade, school, state, teacher's name, and teacher's email. If this information is not included, the entry will be considered ineligible. An entry must be uploaded or postmarked between 12:01 a.m. Eastern Time ("ET") on March 4, 2019, and 11:59 p.m. ET on April 24, 2019 (the "Entry Period"). Mailed entries postmarked within the entry period must be received by 11:59 p.m. ET on May 1, 2019.

- **2. ELIGIBILITY:** The Contest is open only to students in grades 6–8 in a public school, an accredited private school, or a home school in the 50 United States (or the District of Columbia) which is in compliance with the laws and regulations of its state/district and who are residents of the United States (an "Eligible Student"). Students' teachers may also mail in or upload entries on their behalf, if the teacher is 18 or older and a teacher at the student's school ("Submitting Teacher"). Employees of Scholastic Inc. ("Scholastic" or "Sponsor"), Outdoor Power Equipment Institute (OPEI), and members of their immediate families (parents, children, siblings, spouse) or family members living in the same household (whether related or not), their parents, subsidiaries, affiliates, and their advertising, promotion, and production agencies, manufacturers or distributors of Contest materials are not eligible to enter (collectively, "Sponsor and Promotion Parties"). Entries must be the Eligible Entrant's own work. In the event of a dispute over the identity of a Eligible Entrant and/or a Submitting Teacher, entry will be deemed submitted by the holder of the email account submitted in connection with the entry.

- **4. WINNER DETERMINATION:** At the end of the Entry Period, a panel of qualified judges determined by Scholastic and OPEI in their sole discretion will select four (4) winners (Grand Prize, 1st Prize, 2nd Prize, and 3rd Prize) with the highest-scoring entries from among all eligible entries based on the following equally-weighted criteria ("Judging Criteria"):
 - **Effectiveness:** How well the Entry focuses on specific issues and benefits to the community the nature space will serve.
 - **Innovation**: How well the Entry includes creative, original elements.
 - **Personal connection:** How well the Entry explains why the nature space is important to the student.
 - **Presentation:** Each Entry should be neat, organized, and clearly written (and/or drawn). Accurate spelling, grammar, and punctuation will be considered.
- **5. PRIZES:** Four (4) Eligible Students (the "Winners") will be selected from among all the eligible entries received. The Winners, their teacher, and their school will receive cash prizes as follows:

Grand Prize: \$4,000, broken out as follows:

Student: \$2,500Teacher: \$750School: \$750

1st Prize: \$3,000, broken out as follows:

Student: \$2,000Teacher: \$500School: \$500

2nd Prize: \$2,000, broken out as follows:

Student: \$1,500Teacher: \$250School: \$250

3rd Prize: \$1,000, broken out as follows:

Student: \$750Teacher: \$125School: \$125

The decisions of the judges are final and binding. Scholastic reserves the right to not award all prizes if, in its sole discretion, they do not receive a sufficient number of qualified and eligible entries. Sponsor will notify the potential winners to confirm acceptance of the prize. If a potential winner does not agree to the obligations in these Official Rules, Sponsor may award that prize to another Eligible Student at Sponsor's

GENERAL: By entering, the Eligible Student, Submitting Teacher (where applicable) and/or the school receiving a portion of the prize agrees to release and hold harmless Sponsor, and Promotion Parties, and their respective parents, affiliates, subsidiaries, advertising and promotion agencies, prize suppliers, and all others associated with the development and execution of this Contest, and the respective officers, directors, shareholders, agents, and employees of the foregoing (collectively, the "Released Parties") from any and all claims, injuries, damages, or losses to the person or property and/or liabilities of any nature that in any way arise from participation in this Contest or acceptance, use of the prize, participating in or traveling to or from any prize-related activity. The Sponsor is not responsible for delays in receiving or responding to winner prize notifications and such winner/recipient may be disqualified at Sponsor's sole discretion.
