OFFICIAL RULES

NO PURCHASE NECESSARY. SWEEPSTAKES SUBJECT TO THESE OFFICIAL RULES. OPEN TO TEACHERS OVER THE AGE OF 18 (19 IN AL OR NE) WHO ARE EMPLOYED AT A PUBLIC SCHOOL, AN ACCREDITED PRIVATE SCHOOL, OR A HOME SCHOOL IN COMPLIANCE WITH STATE REGULATIONS IN THE 50 UNITED STATES AND D.C. FOR GRADES 3–5 AND WHO ARE RESIDENTS OF THE UNITED STATES.

1. TO ENTER: NO PURCHASE NECESSARY TO ENTER OR WIN. Entrants can enter the **Panda Nation Sweepstakes** (the “Sweepstakes”) in one of two ways. An eligible teacher of grades 3–5 must either visit pandanation.org/wildclassroom, enter their information to create a fundraising page for their classroom and raise a minimum of \$25 through the page OR mail-in their information (first and last name, school name, school email address, email address) on a 3x5 notecard to the following address:

To be considered eligible for entry, each entrant must submit the requested data via the form on the website and raise \$25 OR send their contact information through the mail. If the fields are not completed and the minimum amount of \$25 is not raised OR the mailed-in index card is not completed, the entry will be considered ineligible. An entry must be received between 12:01 a.m. Eastern Time (“ET”) on January 30, 2019, and 11:59 p.m. ET on April 22, 2018 (the “Entry Period”).

2. ELIGIBILITY: The Sweepstakes is open only to teachers over 18 (19 in AL or NE) who at the time of entry are teaching in any or all of grades 3–5 in a public school, an accredited private school, or a home school in the 50 United States (or the District of Columbia) which is in compliance with the laws and regulations of its state/district and who are legal residents of the United States. Employees of Scholastic Inc. (“Scholastic” or “Sponsor”), World Wildlife Fund, and members of their immediate families (parents, children, siblings, spouse) or family members living in the same household (whether related or not), their parents, subsidiaries, affiliates, and their advertising, promotion, and production agencies, manufacturers or distributors of sweepstakes materials are not eligible to enter (collectively, “Sponsor and Promotion Parties”). 4. PRIZES: One (1) entrant (the "Winner") will be selected in a random drawing from among all the eligible entries received. The Winner will receive a library of books (ARV: \$500) for their classroom. Sponsor will notify the Winner to confirm acceptance of the prize. If a potential winner does not agree to the obligations in these Official Rules, Sponsor may award that prize to another entrant at Sponsor's sole discretion. The Winner will be notified on or about May 6, 2019.
