All Kids Outdoors Contest and Sweepstakes

1. TO ENTER: NO PURCHASE NECESSARY TO ENTER OR WIN. To enter the All Kids Outdoors Contest and Sweepstakes (the "Contest and Sweepstakes"), entries may be submitted electronically at scholastic.com/outdoorsallianceforkids or by mail at the below address, but must be submitted only by the entrant's teacher, youth program leader, or parent/legal guardian.

Only the student's teacher, youth program leader, parent/legal guardian may submit an entry. To be considered eligible for entry, each entry must contain the completed entry form with students writing a persuasive essay (no more than two (2) pages long) about why the outdoors are so important to them. The student's essay is required to be accompanied by an illustration.

Online entries must be received between 12:01 a.m. Eastern Time ("ET") on March 18, 2019, and 11:59 p.m. ET on April 19, 2019 (the "Entry Period"). Mailed entries postmarked by April 19, 2019, and must be received by 11:59 p.m. ET on April 26, 2019.

It is essential for the proper and legitimate operation of this Contest and Sweepstakes that each entry must be the student's own original work and cannot contain previously published and/or copyrighted material. If Scholastic Inc. (the "Sponsor") or the Promotion Parties (as defined below) discover at any time, during or after the Contest and Sweepstakes, that an entry contains previously published and/or copyrighted material, the

student and teacher/youth program leader/parent/legal guardian who submitted the entry may be immediately disqualified and may be obligated to immediately return any and all prizes that may have been provided to them in connection with their entries.

## 4. PRIZES:

A. Sweepstakes: One (1) student will be selected in a random drawing from among all eligible entries (the "Sweepstakes Winner"). The Sweepstakes Winner will win \$50 worth of books from Scholastic (ARV \$50). The teacher, youth program leader, parent and/or legal guardian who submitted the

Sweepstakes Winner's entry will receive \$200 in Scholastic credits (shop.scholastic.com) to purchase anything they wish.

Total Sweepstakes ARV \$250.

B. Contest: One (1) student will be selected by a panel of judges (as described below) from among all the eligible entries received (the "Grand Prize Contest Winner"). The Grand Prize Contest Winner will receive: a one-year National Park Pass (ARV \$80); and an Olympic National Park Trip for the Grand Prize Contest Winner and his/ her family and/or friends (up to 4 people for 5 days; 2 of the people must be the Grand Prize Contest Winner and his/her parent or legal guardian), which will include entry fees to the park, private tour of the park, cabin, and meals (ARV \$400 per person, up to \$2,000); and travel expenses up to \$3,000. The Grand Prize Contest Winner will also win \$250 worth of books from Scholastic. The Grand Prize Contest Winner may be profiled in an OAK publication and on the OAK website and social media.

ID and/or other required travel documents, such as a valid passport, at time of travel. The Grand Prize Contest Winner and his/her traveling companions are responsible for obtaining travel documents. If Grand Prize Contest Winner cancels the trip at any time, the Grand Prize Contest Winner agrees to forfeit the Grand Prize immediately, and Scholastic may, in its sole discretion, award the Grand Prize to a runner-up. potential student winner is not awarded a prize, the teacher, youth program leader, parent and/or legal guardian who submitted shall not receive that portion of the prizing either. Winners will be notified on or about May 15, 2019. Winners may be asked to sign an affidavit. The Grand Prize Contest Winner and any traveling companions shall be required to sign a release form prior to travel. The prizes are nontransferable and non-assignable, and no alternative will be offered. Winners should allow approximately six (6) to eight (8) weeks after notification and completion of affidavit for delivery of prizes.

5. JUDGING: The potential Grand Prize Contest Winner and Honorable Mention Winners will be selected from among all eligible entries received by a panel of independent judges based on the following criteria:

Persuasion (80 points):

- How well does the essay explain the importance of the outdoors? (30 points)
- How well does the essay use facts, emotions, and trusted experts to persuade? (30 points)
- How well is the essay organized to express what the writer wants to say? (20 points)

Illustration (20 points): How well does the illustration support the essay in representing the importance of the outdoors?

The decisions of the judges are final and binding. Scholastic and OAK reserve the right to not award all prizes if, in their sole discretion, they do not receive a sufficient number of qualified and eligible entries.
