

SCIENCE IS EVERYWHERE SWEEPSTAKES OFFICIAL RULES

1. **NO PURCHASE NECESSARY.** To enter, simply visit www.scholastic.com/scienceiseverwhere and follow the instructions located there. **Sweepstakes begins April 1, 2008 5:00 p.m. EST and all e-mail entries must be received by May 12, 2008, 4:59 p.m. EST.** One entry per person. To enter, teachers can download the "Science is Everywhere" crossword puzzles and fill them out with their class (answer sheets are also provided online). Once completed, a Mystery Word will be visible (the letters in circles read from top of puzzle to the bottom of the puzzle), teachers must type the correct "Mystery Science Word" into the sweepstakes form online to enter. No copies, facsimiles or reproductions of online entry form will be accepted. **YOU MAY ONLY ENTER THIS SWEEPSTAKES ONLINE. NO OTHER METHOD OF ENTRY WILL BE ACCEPTED.** All entries become the exclusive property of the Sponsor and will not be acknowledged or returned.
